BUILDING CALIFORNIA'S ENERGY FUTURE: CLEAN, AFFORDABLE, RESILIENT AND EFFICIENT





CLEAN: Increased use of Renewable Gas is a key strategy to reduce Greenhouse Gas (GHG) emissions. 
